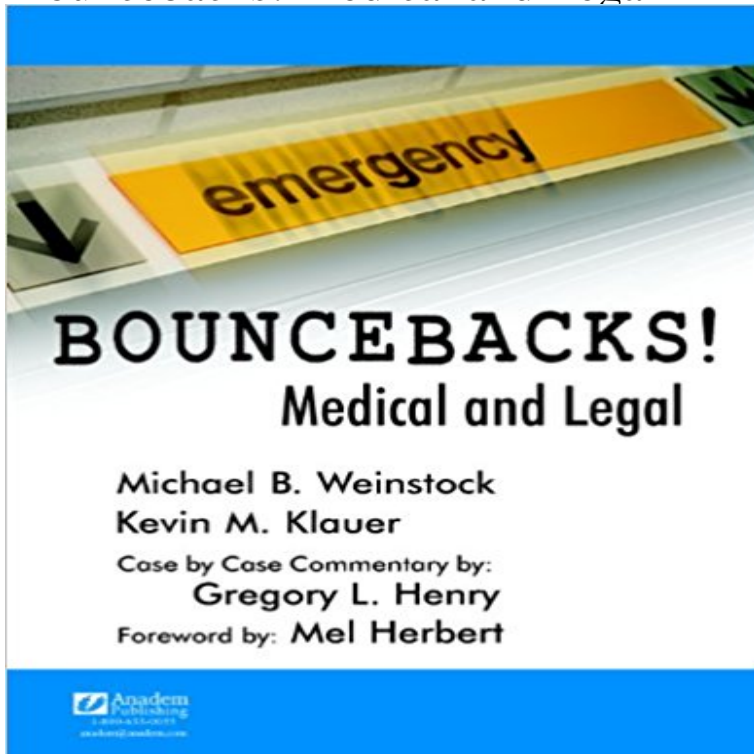


## Bouncebacks! Medical and Legal
